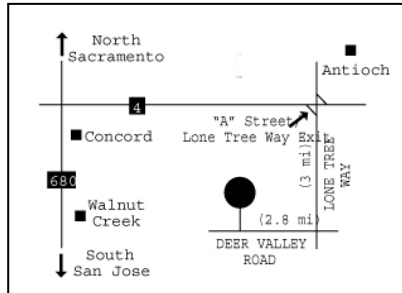

**FORMAT: 18 holes Four-Ball Stroke Play (Two-Person Better Ball).** Play will be from the **BLACK** tees. Qualifiers will advance to the Championship proper at **Spyglass Hill GC** on **May 20-22, 2011**. The number of spots available at each qualifying site will be determined based on the total number of entrants and the final field at each site. Final number of spots will be available from the Committee on the day of qualifying.

**RULES OF PLAY:** The **2010-2011** USGA Rules of Golf are in effect and are supplemented by the NCGA rules card. The committee will provide any additional Local Rules needed at the tee. It is the individual player's responsibility to know the conditions of the competition.

**ONE BALL RULE:** The "One Ball Rule" is **NOT** in effect.

**GOLF CARTS:** Golf cart rental is \$15 per person. **Spectator carts are prohibited.** A maximum of two carts per group is permitted.

**1ST TEE TIME: 8:00 AM off tee 1.** Players should be at their assigned tee 10 minutes prior to their tee time.

**PRACTICE ROUND:** If you wish to play a practice round you must make reservations by calling the golf shop at the number listed above.

**WITHDRAWALS AND NO SHOWS: REGISTRANTS** who wish to **withdraw for any reason MUST notify the NCGA Rules and Competitions Department at (831) 625-4653.** See NCGA rules card.

**Failure to withdraw appropriately** will result in a **NO SHOW** and the player will receive a **ONE-YEAR SUSPENSION FROM ALL NCGA EVENTS FOR THE CALENDAR YEAR FOLLOWING THE INFRACTION.** A player who only contacts the course and NOT the NCGA will incur the suspension. Requests for refunds received by 5 PM Monday, April 11, 2011 will be honored (less 50% handling fee) for contestants withdrawing from the competition. Requests for refunds after this date will not be honored.

**SUBSTITUTIONS:** No substitutions will be accepted after 5 PM Thursday, April 7, 2011. Teams qualifying for the championship are prohibited from making substitutions; however, one partner may represent the team for all or any part of a stipulated round. All substitutions must be made through the **NCGA Championships and Events Department at (831) 625-4653.**

**FOOTWEAR:** Non-metal spikes required. Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

**DRESS CODE:** See NCGA rules card.

**CERTIFICATES:** If you registered by paper and are a qualifier, a certificate will be mailed to you or your partner the day following, whomever was listed first at registration. If you have not received your certificate by Friday, April 22<sup>nd</sup>, please contact us immediately. This certificate must be completed and mailed to the NCGA with an additional \$600 by Friday, April 29<sup>th</sup>.
