

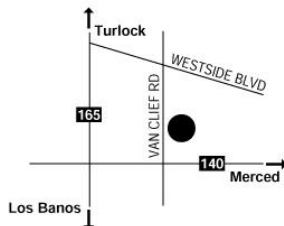

**CLUB LOCATION:**

**FORMAT:** 18 holes stroke play. Contestants will play from the **BLUE** tees. Qualifiers will advance to the championship proper at SPYGLASS HILL GC on April 4-5, 2011. The number of spots available at each qualifying site will be determined based on the total number of entrants and the final field at each site. Final number of spots will be available from the Committee on the day of qualifying.

**RULES OF PLAY:** The 2010-2011 USGA Rules of Golf are in effect and are supplemented by the 2010 NCGA rules card. The Committee will provide any additional Local Rules needed at the tee. It is the individual player's responsibility to know the conditions of the competition.

**ONE BALL RULE:** The "One Ball Rule" is **not** in effect.

**AUTOMOTIVE TRANSPORTATION / CARTS:** Golf carts are **Optional** at the player's expense. Cart rental is \$15 per rider. A maximum of two carts per group are permitted. **SPECTATOR CARTS ARE PROHIBITED.**

**1<sup>st</sup> TEE TIME:** 8:00 AM off of tee 1.

**FOOTWEAR:** Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

**DRESS CODE:** See NCGA rules card either enclosed or online at [www.ncga.org](http://www.ncga.org).

**PRACTICE ROUNDS:** If you wish to play a practice round you must make reservations by calling the Stevinson Ranch GC golf shop at the number listed above.

**WITHDRAWALS AND NO SHOWS:** **REGISTRANTS** who wish to **withdraw for any reason MUST** notify the NCGA Rules and Competitions Department at (831) 625-4653. See NCGA rules card.

**Failure to withdraw appropriately** will result in a **NO SHOW** and the player will receive a **ONE-YEAR SUSPENSION FROM ALL NCGA EVENTS FOR THE CALENDAR YEAR FOLLOWING THE INFRACTION.** A player who only contacts the course and NOT the NCGA will incur the suspension.

**CERTIFICATES:** If you registered by paper and qualify, a certificate will be mailed out in the days following. If you have not received your certificate by Friday, March 18<sup>th</sup> please contact us immediately. This certificate must be completed and mailed to the NCGA with an additional \$250 by Wednesday, March 23<sup>rd</sup>.

**ONLINE REGISTRANTS:** If you registered online and qualified for the championship, you will not be mailed a certificate. Your spot will be confirmed via e-mail and your credit card will automatically be charged the \$250 Championship fee.
