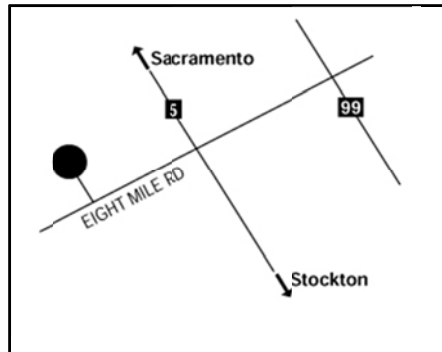

**FORMAT:** 18 hole stroke play. Contestants will play from the **GOLD** tees. Qualifiers will advance to the CHAMPIONSHIP proper at Spyglass Hill GC on August 13-17, 2012. The number of spots available at each qualifying will be determined based on the total number of entrants and the final field at each site. Final number of spots will be available from the Committee on the day of qualifying.

**RULES OF PLAY:** The 2012-2015 USGA Rules of Golf are in effect and are supplemented by the NCGA rules card. The committee will provide any additional Local Rules needed at the tee. It is the individual player's responsibility to know the conditions of the competition.

**ONE BALL RULE:** The "One Ball Rule" is not in effect.

**GOLF CARTS:** The use of automotive transportation is prohibited for all players, caddies, and spectators.

**1<sup>st</sup> TEE TIME:** 8:00 AM off tee 1. Players should be at their assigned tee 10 minutes prior to their tee time.

**PRACTICE ROUND:** If you wish to play a practice round you must make reservations by calling the golf shop at the number listed above.

**WITHDRAWALS AND NO SHOWS:**

**REGISTRANTS** who wish to **withdraw for any reason MUST notify the NCGA CHAMPIONSHIPS & Events Department at (831)625-4653.** See NCGA rules card or visit the CHAMPIONSHIPS and Events page on [www.ncga.org](http://www.ncga.org). A player who only contacts the course and NOT the NCGA will incur the infraction.

**Failure to withdraw appropriately** will cause the player to be listed as a **NO SHOW** and result in a **ONE-YEAR SUSPENSION FROM ALL NCGA EVENTS FOR THE CALENDAR YEAR FOLLOWING THE INFRACTION.**

**LATE APPEARANCE:** Starters will not page players in advance of their starting time. Players are solely responsible for knowing their starting times and all players in a group must be present and ready to play at the time laid down by the Committee. The order of play is not relevant.

**FOOTWEAR:** Non-metal spikes are required.

**CERTIFICATES/CHAMPIONSHIP FEE:**

**Online registrants:** If you registered online, and are a qualifier, you will not be mailed a certificate. Your credit card will automatically be charged the \$300 CHAMPIONSHIP fee.

**Paper registrants:** If you registered by paper, and are a qualifier, a certificate will be mailed to you. If you have not received your certificate by Friday, July 27<sup>th</sup>, please contact us immediately. This certificate must be completed and mailed to the NCGA at the PO Box listed on the certificate with an additional \$300 by August 3, 2012.
