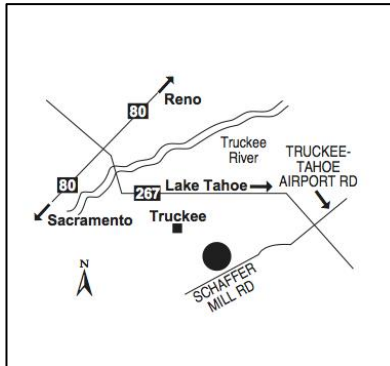


## CONTESTANT INFORMATION SHEET

Listed below is IMPORTANT tournament information pertinent to the qualifying site where you have been assigned.

**FORMAT: 36 holes stroke play.** Contestants will play from the **BLACK** tee markers wherever they are situated. (See attached yardage sheet). The low individual scores will advance to the Championship proper at the The Country Club in Brookline, Massachusetts, August 12-18, 2013. There will be a play-off immediately following play to determine the last qualifying spot and/or two alternates if necessary. The final number of qualifiers will be announced on the day of qualifying.

**TEE TIMES:** Starting at 7:30 AM / 1:00 PM on Tee 1 and 10.

**RULES OF PLAY:** The 2012-2015 USGA Rules of Golf are in effect and are supplemented by the USGA Hard Card. The Committee will provide any additional Local Rules needed at the qualifying or championship site. It is the individual player's responsibility to know the conditions of the competition.

**LIMITATION OF GOLF BALLS ("ONE BALL"):** Optional condition as prescribed in Appendix I shall be in effect.

**AUTOMOTIVE TRANSPORTATION:** The use of automotive transportation is prohibited. Pull carts are permitted. Spectator carts will not be allowed. **EXCEPTION:** Shuttles will be provided for players and caddies between several holes.

**ELECTRONIC MEASURING DEVICES:** The local rule is NOT in effect. **Players will not be allowed to use them.** Penalty for breach of this condition: **DISQUALIFICATION.**

**DRESS CODE: PLAYERS, CADDIES and SPECTATORS** must be properly attired both on the golf course and premises of the club. Blue jeans, designer jeans, T-shirts and tank tops are prohibited. Collared shirts must be worn and be tucked. Shorts, if worn, must be no shorter than mid-thigh (no jean shorts). **DRESS CODE IS THE SAME FOR MEN AND WOMEN.**

**FOOTWEAR:** Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

**PRACTICE ROUNDS:** Practice rounds are available any day from 10:30 AM – 1:50 PM by calling the golf shop at the number above. For contestants only the greens fee is \$20 including cart. Guests are permitted at a greens fee of \$185 including cart.

**PRO SHOP:** The Pro Shop opens at 6:30 AM on the day of the competition.

**DRIVING RANGE:** The Driving Range opens at 6:30 AM on the day of the competition.

**FOOD SERVICE:** A limited breakfast menu will be available as well as lunch and snacks throughout the day at Peg's at Poolside.

**LOCKER ROOM:** The locker room and pool facilities are NOT available to contestants.

**REFUNDS:** The USGA will refund the entry fees in the event of injury or illness, if requested by August 12, 2013. A \$30.00 service charge will be deducted from all refunds. No refunds for any reason after August 12, 2013. **REQUESTS FOR REFUNDS MUST BE DIRECTED TO THE USGA AT (908) 234-2300.**
