



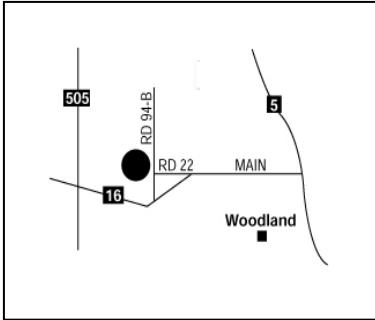

CONTESTANT INFORMATION SHEET

RULES OF PLAY: The 2012-2015 USGA Rules of Golf as supplemented by the USGA Junior Amateur Championship application, the USGA Local Rules and Conditions of Competition for 2013 Championships and the Local Rules published by the Committee will govern all play.

FORMAT: The competition will consist of **two 18-hole rounds** of stroke play (gross). Play will be from the **BLACK** tee markers at the enclosed yardages (BLUE yards used on holes #1, #10, #14 and #18). Ties for qualifying/alternate positions will be broken by a playoff commencing immediately following completion of the two stipulated rounds. The top **4** individuals will advance to the championship to be held at **Martis Camp Club** in **Truckee, California** on **July 22-27, 2013**.

ONE BALL RULE: The optional condition as prescribed in Appendix I shall be in effect.

STARTING TIMES: Your starting time and tee assignment for both rounds are on the included pairings list. Please note that we will be starting on both the 1st and 10th tees. **All players are expected to report to the starter a minimum of 5 minutes prior to their scheduled starting time to receive information on local rules, hole locations, etc.** Starters will not "call" players to the tee. You are solely responsible for knowing your starting time, tee assignment and prompt appearance.

PRACTICE ROUNDS: Practice rounds are available by contacting the Yolo Fliers Pro Shop (530) 662-8050 to arrange a tee time. Reservations accepted starting June 19th at 8:00AM. Please identify yourself as a U.S. Junior Qualifying participant when calling. Green fees: complimentary for players after 1 PM on Saturday, June 22 or Sunday June 23. If a contestant plays with a guest, the guest will pay a \$55 green fee. Arrangements can be made at the discretion of the Pro Shop if contestants cannot play on either of the practice round dates, however, they must pay the \$55 green fee. Cart fee during the practice round will be \$24 (**No carts allowed the day of qualifying**).

DRESS CODE: Players and caddies must be properly attired on the course and the club premises. Blue jeans, designer jeans, T-shirts, cutoffs and tank, halter or tube tops are prohibited. Men's shirts must be collared. Shorts must reach to mid-thigh.

FOOTWEAR: NO METAL SPIKES ALLOWED. Penalty for breach of this condition: **DISQUALIFICATION.**

GOLF SHOP & PRACTICE RANGE: The Golf Shop and Practice Range will be open at 6:00 AM. Range Balls will be provided for the players.

SPECTATORS: Spectators are welcomed throughout the competition. They must remain at least 25 yards from any competitor and may not provide advice during the play of either round. Violation of this prohibition could result in the disqualification of the player. Spectator carts will not be permitted.

AUTOMOTIVE TRANSPORTATION: The use of automotive transportation is prohibited for both players and caddies. Players AND caddies must walk. Push/pull carts are permitted.

CADDIES: Players are reminded that a competitor's parent, stepparent or guardian may *not* caddie for him. Siblings may caddie for a competitor. Yolo Fliers Club does not have caddies available for hire.

DISTANCE MEASURING DEVICES: Distance measuring devices, including GPS based systems and laser rangefinders are **not permitted**. The penalty for use is **DISQUALIFICATION**.

FOOD SERVICE: Yolo Fliers will provide a BBQ lunch that will be complimentary for players and available for purchase by caddies and spectators for \$12. **CASH ONLY** will be accepted for meals. Breakfast WILL NOT BE AVAILABLE for purchase.

REFUNDS: The USGA will refund entry fees in the event of injury or illness, if requested by July 22, 2013. A \$30 service charge will be deducted from all refunds. No refunds for any reason after July 22, 2013.
