



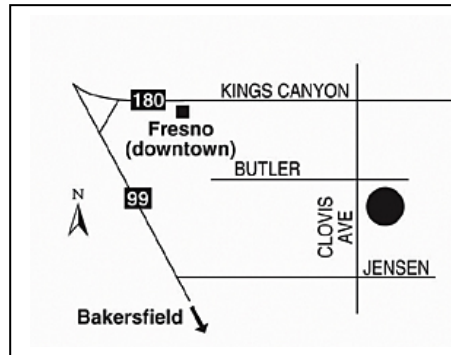

CONTESTANT INFORMATION SHEET

Listed below is IMPORTANT tournament information regarding the qualifying site where you have been assigned.

FORMAT: 18 holes of stroke play. Contestants will play from the **BLUE** tee yardage. The low TBD individual scores will advance to Sectional Qualifying held at Big Canyon Country Club in Newport Beach, California or another site if requested. There will be a playoff immediately following play to determine the last qualifying spot and/or alternates if necessary. The Championship will be held at Merion Golf Club in Ardmore, PA on June 13-16, 2013.

RULES OF PLAY: The 2012-2015 USGA Rules of Golf are in effect and are supplemented by the enclosed USGA Rules card. The Committee will provide any additional Local Rules needed at the qualifying site. It is the player's responsibility to know the conditions of the competition.

ONE BALL RULE: Optional condition as prescribed in Appendix I shall be in effect.

ELECTRONIC MEASURING DEVICES: The local rule is **NOT** in effect. **Players will not be allowed to use them.** Penalty for breach of this condition: **DISQUALIFICATION.**

AUTOMOTIVE TRANSPORTATION: **The use of automotive transportation is prohibited for both players and caddies.** Players AND caddies must walk. Pull carts are allowed.

DRESS CODE: Players and Caddies must be properly attired both on the golf course and premises of the club. Blue jeans, designer jeans, t-shirts and tank tops are prohibited. Golf shirts must be worn and shorts must be no shorter than mid-thigh (no jean shorts).

FOOTWEAR: Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. **NO METAL SPIKES ALLOWED.** Penalty for breach of this condition: **DISQUALIFICATION.**

PRACTICE ROUNDS: Practice rounds are available and please contact the Sunnyside Golf Shop to schedule one. Please call the Golf Shop at (559) 255-6871 to arrange a tee time. Please identify yourself as a U.S. Open Qualifying participant when calling. Green fees: Any time prior to qualifying after 1pm - \$50, cart fee is \$16 per player. **(No carts allowed the day of qualifying)** NO GUESTS.

GOLF SHOP & PRACTICE RANGE: The Golf Shop and Practice Range will be open at 7:00 AM. Range balls will be provided for the players.

FOOD SERVICE: The snack bar will be open from 7:00AM until the conclusion of play.

MISC. INFO: Cash, credit cards, and reciprocal charges are accepted in the golf shop and snack bar. **Spectator carts will not be permitted.**

WITHDRAWALS: Notify the NCGA Rules and Competitions Department at (831) 625-4653.

REFUNDS: The USGA will refund the entry fee in the event of injury or illness if requested by June 3, 2013. A \$30 service charge will be deducted from all refunds. No refunds for any reason after June 3, 2013. **REQUESTS FOR REFUNDS MUST BE DIRECTED TO THE USGA AT (908) 234-2300.**
