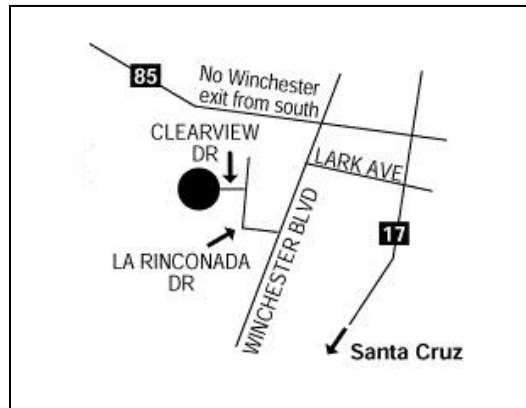


CONTESTANT INFORMATION SHEET

Listed below is IMPORTANT tournament information pertinent to the qualifying site where you have been assigned.

FORMAT: 18 holes of stroke play. Contestants will play from the **Burgundy** tee yardages. The low **4** individual scores will advance to the Championship proper at **Wade Hampton Golf Club in Cashiers, NC** on **September 21 – 26, 2013**. There will be a playoff immediately following play to determine the last qualifying spot and/or alternates if necessary.

RULES OF PLAY: The **2012-2015** USGA Rules of Golf are in effect and are supplemented by the USGA Rules Card. The Committee will provide any additional Local Rules needed at the qualifying site. It is the player's responsibility to know the Conditions of the Competition.

LIMITATION OF GOLF BALLS ("ONE BALL"): Optional condition as prescribed in Appendix I shall be in effect.

ELECTRONIC MEASURING DEVICES: The local rule is **NOT** in effect. **Players will not be allowed to use them.** Penalty for breach of this condition: **DISQUALIFICATION.**

AUTOMOTIVE TRANSPORTATION: **\$20 per player. The use of automotive transportation is permissible for players only.** Caddies must walk at all times during the stipulated round. **SPECTATOR CARTS ARE ALSO PROHIBITED.**

DRESS CODE: **Players and Caddies** must be properly attired both on the golf course and premises of the club. Blue jeans, designer jeans, t-shirts and tank tops are prohibited. Golf shirts must be worn and shorts must be no shorter than mid-thigh (no jean shorts). **DRESS CODE IS THE SAME FOR MEN AND WOMEN.**

FOOTWEAR: Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

PRACTICE ROUNDS: Available to contestants and guests after 2:30 PM Tuesday - Thursday. Green fee is \$90 and cart fee is \$18 per player. Cash, credit card or reciprocal club charges only. Please call the Pro Shop to arrange for practice round tee times and identify yourself as a participant in the USGA Senior Amateur Sectional Qualifier.

GOLF SHOP & PRACTICE RANGE: The Pro Shop will open at 8:00 AM and driving range will open at 8:00 AM.

FOOD SERVICE: No breakfast available on the day of qualifying. A \$20 (cash only) lunch buffet will be available from 12:30-3:30.

WITHDRAWALS: Notify the NCGA Championships and Events Department at (831) 625-4653.

REFUNDS: The USGA will refund the entry fee in the event of injury or illness if requested by September 29, 2012. A \$30 service charge will be deducted from all refunds. No refunds for any reason after September 29, 2012. **REQUESTS FOR REFUNDS MUST BE DIRECTED TO THE USGA AT (908) 234-2300.**
