



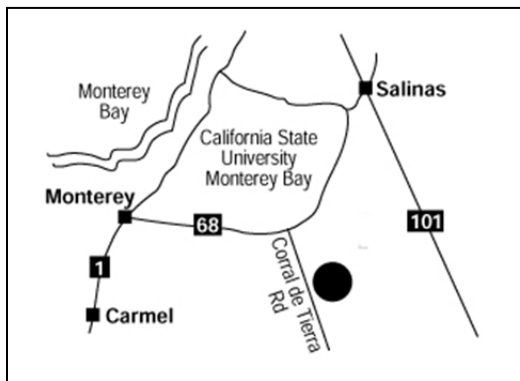

CONTESTANT INFORMATION SHEET

Listed below is IMPORTANT tournament information pertinent to the qualifying site where you have been assigned.

**CLUB LOCATION:**

**FORMAT:** 18 hole stroke play. Contestants will play from the **BLACK** tees. The low individual scores will advance to the championship. Final qualifying numbers will be available from the starter. There will be a playoff immediately following play to determine the last qualifying spot and/or alternates if necessary. The Championship will be held at Omaha CC in Omaha, NE July 11-14, 2013.

**FIRST TEE TIME:** 7:30 AM off tee #1 and #10. Players should be at their assigned tee 10 minutes before their tee time.

**RULES OF PLAY:** The 2012-2015 USGA Rules of Golf are in effect and are supplemented by the USGA Hard Card. The Committee will provide any additional Local Rules needed at the qualifying or championship site. It is the individual player's responsibility to know the conditions of the competition. **The "One-Ball-Rule" is in effect.**

**ELECTRONIC MEASURING DEVICES:** The local rule is **NOT** in effect. **Players will not be allowed to use them.** Penalty for breach of this condition: **DISQUALIFICATION.**

**AUTOMOTIVE TRANSPORTATION:** **The use of automotive transportation is prohibited.** Pull carts are permitted. Spectator carts will not be allowed.

**DRESS CODE:** **PLAYERS, CADDIES** and **SPECTATORS** must be properly attired both on the golf course and premises of the club. Blue jeans, designer jeans, T-shirts and tank tops are prohibited. Collared shirts must be worn and be tucked. Shorts, if worn, must be no shorter than mid-thigh (no jean shorts). **DRESS CODE IS THE SAME FOR MEN AND WOMEN.**

**FOOTWEAR:** Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

**PRACTICE ROUNDS:** Available through June 23. Contestants only; Contestants must call the pro shop at the number listed above to make reservation **ONE WEEK IN ADVANCE.** Please identify yourself as a US Senior Open Contestant. Cost: One round per amateur is comped, additional practice rounds are \$50; PGA – Comp.

**PRO SHOP & RANGE:** The Pro Shop will open at 6:30 AM and driving range at 6:30 AM on the day of the competition.

**FOOD SERVICE:** A no host breakfast buffet will be available. The snack bar will open for lunch. Cash, credit or reciprocal charges will be accepted.
