



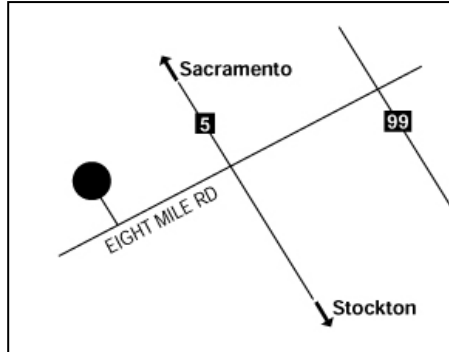

CONTESTANT INFORMATION SHEET

Listed below is IMPORTANT tournament information regarding the qualifying site where you have been assigned.

FORMAT: 18 holes of stroke play. Contestants will play from the **WHITE** tee markers at a combination of Blue/White yardages (please see attached sheet). The low individual scores will advance to the Championship which will be held at **The Jimmy Austin OU Golf Club in Norman, Oklahoma on June 17 - 22, 2013**. There will be a playoff immediately following play to determine the last qualifying spot and/or alternates if necessary.

RULES OF PLAY: The **2012-2015** USGA Rules of Golf are in effect and are supplemented by the USGA Rules card. The Committee will provide any additional Local Rules needed at the qualifying site. It is the player's responsibility to know the conditions of the competition.

ONE BALL RULE: Optional condition as prescribed in Appendix I shall be in effect.

ELECTRONIC MEASURING DEVICES: The local rule is **NOT** in effect. **Players will not be allowed to use them.** Penalty for breach of this condition: **DISQUALIFICATION.**

AUTOMOTIVE TRANSPORTATION: **The use of automotive transportation is prohibited for both players and caddies. Players AND caddies must walk.**

DRESS CODE: **Players and Caddies** must be properly attired both on the golf course and premises of the club. Blue jeans, designer jeans, t-shirts and tank tops are prohibited. Golf shirts must be worn and shorts must be no shorter than mid-thigh (no jean shorts).

FOOTWEAR: Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. **NO METAL SPIKES ALLOWED.** Penalty for breach of this condition: **DISQUALIFICATION.**

PRACTICE ROUNDS: Practice rounds are currently available and players are to contact the Reserve GC at Spanos Park Pro Shop to schedule one. Please call the Pro-Shop at (209) 477-4653 to arrange a tee time and identify yourself as a U.S. Women's Amateur Public Links Qualifying participant when calling. **Green fees: \$35 including cart. (No carts allowed the day of qualifying).**

GOLF SHOP & PRACTICE RANGE: The Golf Shop and Practice Range will be open at 6:00 AM. Range Balls will be provided for the players.

FOOD SERVICE: Accents Restaurant will be open beginning at 6:00AM. Full menu will be available for breakfast and lunch.

MISC. INFO: Cash, and credit cards are accepted in the pro shop and in the grill. **Spectator carts will not be permitted.**

WITHDRAWALS: Please notify the USGA at (908) 234-2300 to withdraw.

REFUNDS: The USGA will refund the entry fee in the event of injury or illness if requested by June 17, 2013. A \$30 service charge will be deducted from all refunds. No refunds for any reason after June 17, 2013. **REQUESTS FOR REFUNDS MUST BE DIRECTED TO THE USGA AT (908) 234-2300.**
