



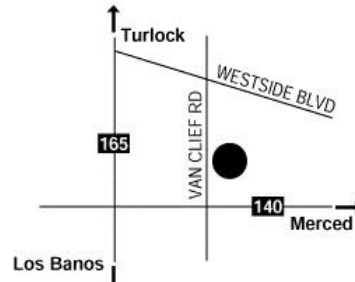

CONTESTANT INFORMATION SHEET

Listed below is IMPORTANT tournament information. Please read carefully.

FORMAT: 18 hole stroke play. Contestants will play from the **BLACK** tees. The low individual scores plus two alternates will advance to the Championship proper at Monterey Peninsula Country Club on June 17-22, 2013.

NOTE: The final number of spots at each course will be announced by the committee. Any playoffs will take place immediately after the conclusion of play for the last spot and the two alternates.

RULES OF PLAY: The 2012-2015 USGA Rules of Golf are in effect and are supplemented by the CGA rules card. The Committee will provide any additional Local Rules needed at the tee. It is the individual player's responsibility to know the conditions of the competition.

ONE BALL RULE: The "One Ball Rule" is **NOT** in effect.

AUTOMOTIVE TRANSPORTATION: This is a walking-only event. **SPECTATOR CARTS ARE PROHIBITED.** Caddies are welcome, but not available through the pro shop.

DRESS CODE - PLAYERS, CADDIES AND SPECTATORS: The NCGA Dress Code on the NCGA Rules Card located on the web page is to be followed.

FOOTWEAR: Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

GLOBAL POSITIONING SYSTEMS AND HAND HELD RANGE FINDERS. A player may obtain distance information by using a device that measures distance only. However, if, during a stipulated round, a player uses a device that is designed to gauge or measure other conditions that might affect his play (e.g. gradient, wind-speed, temperature, etc), the player is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such additional functions are actually used.

PRACTICE ROUNDS: Practice rounds are available by contacting the Stevinson Ranch GC pro shop at the phone number listed above. Please identify yourself as a CGA contestant when reserving times.

PRO SHOP & RANGE: Both open at 7:00 AM. Range balls are complimentary.

FOOD & BEVERAGE: Restaurant access will be available starting at 7:00 AM. Breakfast and lunch will be available off the menu. Drinks and snacks will also be available throughout the day.

PAYMENTS: Cash and Visa/Mastercard/Amex. **CLUB DOES NOT ACCEPT DISCOVER CARDS.**

WITHDRAWALS AND NO SHOWS: Refer to NCGA Rules Card.

LODGING: Call (209) 668-8200 to reserve.

ONLINE AND PAPER REGISTRANTS who wish to **withdraw for any reason MUST notify the NCGA Championships and Events Department at (831) 625-4653. Failure to withdraw appropriately will result in a NO SHOW and the player will receive a ONE-YEAR SUSPENSION FROM ALL CGA EVENTS FOR THE CALENDAR YEAR FOLLOWING THE INFRACTION.** A player who only contacts the course and NOT the NCGA will incur the suspension.
